**Melissa Gomez** *she/her,* PACT Project Director, Child and Family Policy Institute of California

Melissa Gomez has contributed 20 years of service to the anti-trafficking movement. Her international and local leadership has been instrumental in establishing multi-disciplinary coalitions and in coordinating comprehensive care to survivors of both labor and sex trafficking in Europe and the Central Valley, California. As the Chair of the Central Valley Freedom Coalition and Program Manager of Fresno's Central Valley Against Human Trafficking, she contracted with

partnering agencies to provide services throughout six central valley counties. Additionally, she acted as regional liaison to facilitate 24-7 trauma response in partnership with Polaris' National Human Trafficking Hotline. Melissa is dedicated to the advancement and integration of diverse voices to pioneer systemic change and co-create pathways of empowerment. In 2018 Melissa was selected to participate in the first cohort of the Human Trafficking Leadership Academy administered by the United States Department of Health and Human Services, where she contributed to national guidance on survivor informed practices within federal grant programs. In 2020, Melissa was recognized with an Outstanding Service Award by the CDSS for her efforts to increase awareness and improve services to survivors of child labor trafficking. Ms. Gomez is currently the acting Director of the Preventing and Addressing Child Trafficking Project for the Child and Family Policy Institute of California. In partnership with the California Department of Social Services (CDSS), she facilitates a statewide model of cross-coordination strengthening child welfare programs serving vulnerable children and youth within California. Melissa resides in Ripon, California and is the proud mother of two creative boys.

## Session I Building Resilience Through Harm Reduction: Working with Sexually Exploited and Trafficked Youth People, Regency F Ballroom



**Dr. Brandi Lilles** *she/her*, Psychologist, CAARE Diagnostic and Treatment Center, UC Davis Children's Hospital Dr. Brandi D. Liles is a licensed clinical psychologist at the CAARE Center in the Pediatric Department of the UC Davis Children's Hospital. Over the course of her career, Dr. Liles has developed an expertise in working with children, youth, young adults and their families who have experienced trauma and maltreatment including commercial child sexual exploitation. She has worked extensively with socially, culturally and economically diverse and disadvantaged children and families. In addition to providing evidence-based assessment and treatment to

clients, she provides training and consultation for students, interns, community providers, and child welfare and juvenile justice system partners in a variety of topics related to trauma-responsive care.



**Dr. Dawn Blacker** *she/her,* Interim Co-Director, Training Director, Psychologist, CAARE Diagnostic and Treatment Center, UC Davis Children's Hospital

Dr. Dawn Blacker is a clinical psychologist and Interim Co-Director of Mental Health Services at the UC Davis CAARE Center as well as the Training Director of the APA-Accredited Psychology Internship in the Department of Pediatrics, University of California Davis Children's Hospital. Over the past 23 years, Dr. Blacker's primary clinical and research interests have focused on issues of abuse and neglect within

the family context as well as issues related to training clinicians in evidenced based practices. As a senior psychologist, Dr. Blacker provided individual therapy services such as Parent-Child Interaction Therapy, Trauma Focused Therapy, and Dialectical Behavior Therapy as well as Evaluation services for clients with very diverse social, cultural and economic backgrounds. As the Training Director of the CAARE Center, Dr. Blacker spends much of her time providing training and consultation to early career staff through the APA accredited Psychology Internship. She is also a master trainer of Parent Child Interaction Therapy and has trained others in PCIT for numerous clinicians. Dr. Blacker is also involved in the training of professionals including clinicians on providing services for sexually exploited youth. She oversees 4 contracts with Sacramento County (Probation; Child Protective Services; Behavioral Health; Public Defenders' Office) that provide training and

services for sexually exploited youth and their caregivers. Dr. Blacker has also co-developed a web course on sexual exploitation as well as a Caregiver Skills Group curriculum for caregivers caring for youth with a history of sexual exploitation. She is currently working on two project for California Department of Social Services focused on content for resource families and professionals working with CSEC youth.

As the Associate Director of the Child and Family Policy Institute of California, Andrea provides project and team-based coaching, facilitation, and consultation to counties and teams, leveraging the CPM and other innovations to improve practice and system effectiveness and to counteract racialized outcomes for families, children, and among those engaged in the work.

In particular, she has been pivotal in the collaboration to bring The Cool Aunt Series, a Human Trafficking prevention curriculum, to the county. Leann is the Youth Engagement Project (YEP) Program Coordinator and has successfully expanded the program into its second year. Her work with the YEP program supported the development of a Foster Youth Education Mentor Program, which provides early intervention to children in middle school by working with a youth with lived experience. Further, Leann has been instrumental in the county's efforts to address Labor Trafficking and develop a coordinated community response to Trauma Informed services and supports in San Luis Obispo County. Leann's creative and enduring commitment to service has supported and improved outcomes for children and families in her community.

Pilar Ortega is a former foster Youth and youth advocate from San Luis Obispo County, CA. Pilar is a youth ambassador and chair president of the San Luis Obispo County Youth Empowerment Program (YEP) where she uses her lived experience of growing up and aging out of the foster care system to empower and inspire others. Through her work with YEP, Pilar engages with youth, school systems, and schools to

facilitate the human trafficking curriculum, The Cool Aunt Series. In addition to this work through YEP, Pilar has also supported projects related to cultural inclusivity and community advancement to provide ongoing support to child welfare agencies. Pilar Ortega is also an Americorps partner where she serves as a youth mentor and partners with county agencies focused on family strengthening and linkages. As a youth mentor, she provides peer support to foster and at-risk youth. Pilar is passionate about making a difference in the foster care system and in the community. In her free time, Pilar is an artist and enjoys going to the beach with her family and friends where she can be outdoors and in nature.

Option 3: Flipping the Script: How Advanced Recovery Planning Can Increase Survivor Engagement

RST is a team of regionally assigned Resource Specialists who provide case-based assistance and support to child welfare professionals and other multidisciplinary team members in the development of trauma-informed and victim-centered recovery plans for survivors of child sex trafficking who are reported missing to

NCMEC. Prior to joining the team at NCMEC, Courtney was a sworn law enforcement investigator in Connecticut and served as the law enforcement liaison to Connecticut's Human Anti-Trafficking Response Team (HART). During this time, she facilitated countless investigation into child sex trafficking, CSAM, and other forms of child abuse. Courtney has provided training and technical assistance throughout Connecticut and nationally on child sex trafficking identification and response. She is pursuing her degree in Public Safety Administration and is passionate about bridging the gap between law enforcement and child welfare.

Having worked for CWS in various roles for almost ten years, Nikki has experience working with families in each step of the court process. In her role as the CSEC Clinician, Nikki provides clinical support to youth identified as victims or at high risk of human trafficking (HT) and works

closely with social workers throughout the agency to ensure that youth are being screened

for HT risk and receiving appropriate services to ensure ongoing safety and support. Nikki facilitates monthly stakeholder meetings to provide opportunity for collaboration between CWS staff, law enforcement, and other service providers. Nikki has a passion for educating others about HT and is the Outreach Subcommittee Lead on the Tulare County Human Trafficking Task Force (TCHTTF), where she has helped develop and present training about human trafficking throughout Tulare County. Along with partners of the TCHTTF, Nikki helped to develop a screening tool for labor trafficking of minors, as well as a supporting user guide and video, which are available for public use on the Task Force's website. Outside of her work with CWS, Nikki is an Adjunct Professor in the Social Work Department at Liberty University. Nikki is an advocate for work-life balance and enjoys serving at her church, spending time with her husband and two young daughters, and baking.

Kelly Amend has been an advocate, trainer, and cheerleader for education on human trafficking since 2012. Previously, Kelly served as Tulare County's Human Trafficking Task Force Coordinator under the Office for Victims of Crime Enhanced Collaborative Model Anti-Trafficking award where she led a task force of three local direct

service providers, six local law enforcement agencies, and four federal agencies along with a community coalition of individuals and organizations working together to prevent and stop human trafficking.

She has conducted numerous workshops, strategic partner training, and awareness events to engage in effective responses to labor and sex trafficking in the Central Valley of California. Her previous experiences include developing the prevention education program at the Central Valley Justice Coalition, working with foster and incarcerated youth as a trained facilitator in Fresno County Juvenile Justice Campus, and as Administrative and Marketing Director at Lanna Coffee Company- a wholesale coffee company focused on seeking transformation of lives through a social enterprise model within specialty coffee. As a graduate of Fresno Pacific University, she had a career as a children's Librarian before transitioning into human trafficking prevention work in 2014. Kelly continues to serve on the Board of the Lanna Foundation helping improve the lives of coffee farmers and hill tribe peoples in Northern Thailand. She can also be found supporting her husband's coffee shop, by drinking lots of fairly sourced cups of coffee and thinking about ways to improve our global supply chains. Today, Jess resides on Tongva territory or colonially known as Long Beach, CA. They are a birth and abortion doula, prison abolitionist and harm reductionist whose activism centralizes community health based economic justice, healing justice, disability justice, Indigenous sovereignty, Trans liberation, and the dignity, and self-determination of people impacted by drug use.

Jess has fifteen years of advocacy in the anti-trafficking and sex worker rights movement, serving in the following leadership roles: Training/Technical Assistance, Communications, Capacity Building and Policy and Program Development consultant and later, as the Artisan Relations and In-House Production team manager, lead product developer and social justice communications specialist with The Little Market, the Survivor Leadership Program Coordinator at the Coalition to Abolish Slavery and Trafficking (CAST) co-coordinating a self-determination group for LA- based labor trafficking survivors and coordinating a national human trafficking survivor network organizing for social chafe rooted in labor rights, peer developed programming and outreach, displacement/im/migration protections, harm reduction, de/anti criminalization, racial, gender and sexuality equity.
